EPA/ADI is not responsible for the costs of any services, accommodations, and special program venues arrangements made by Participant independently of EPA/ADI through Participant's contacts. Nor is EPA/ADI liable for any such independent arrangements.

* **AIRLINE DEVIATION:** This is an individual's different return date than the original contracted group tour return date. The chosen individual's different return date **MUST DEPART** from the **SAME CITY** as the original contracted group return. Depending upon the airline contracted for the tour, ONLY A MAXIMUM OF 10-20% of the group members can choose the Airline Deviation option to maintain the special contracted group fare.

2. COST & SCHEDULE OF PAYMENTS

PAYMENTS ARE TO BE MADE IN THE FORM OF A SINGLE CHECK, COVERING ALL INDIVIDUALS, PAYABLE TO "ADI TOURS". EPA/ADI will not accept any separate payments by any Individual unless mutually agreed upon by EPA/ADI and Participant.

If the signed Contract and Deposit Fee is received by, the costs of the EPA/ADI Program will not change for any reason (including unforeseen monetary fluctuations or changes in costs of services and accommodations), **unless the minimum/maximum numbers of full paying individuals change from the numbers agreed upon in the Contract.**
